Additional informations: PEL Pintossi Spa evaluates constantly the legislative obligations to which undergoes, for the purposes of REACH regulation and RAEE, RoHS norms as manufacturer and end user of products with steel industry and componentry nature.

The raw material used by PEL, such as ferrous and non ferrous alloy bars (steel, brass and aluminium bars), is machined only by chips removal without direct intervention that may modify the chemical composition of the initial alloy. Both raw materials and finished products have to be considered as "items without intentional release of substance" and so not subject to pre-registration bond.

In consideration of the above it is logical assume that REACH regulation will have minimal or null effects on PEL Pintossi production processes. Out of the substances identified until the date of this declaration, none is included in any PEL product.
